  - d. Bob Lennartz is working with Senator Young on a press announcement.
  - **e.** Legislator Chairman John Mills and Bob Lennartz will be meeting to discuss a media release plan. I've also engaged the Ellicottville Chamber to work on the best way to get out the message in Cattaraugus County.

## 5. Brochure Printing

- 6. Capital Project for Southern Erie and Cattaraugus counties:
